## **Product Description**

Clearspan Ali sheet balustrade utilises either solid, perforated or router cut 4mm aluminium sheet fitted into the clearspan frame. This is a simple & effective way to provide privacy, protection and the aesthetic look from a sheet infill. All Clearspan styles offer varying handrail options and fixing methods. Aluminium is extruded locally and fixings are high grade 316 stainless steel.

The system is suitable for residential, commercial\*, external, internal & pool fence applications.

- Face fixed
- Top fixed
- Gutter Bracket (Castaway)

Surface finishes can be power coated or anodized in a range of standard colours.

## Conditions of use

Clearspan Ali Sheet must be installed by Spectrum or an approved installer, and as per fixing details provided by Spectrum.

Suitability for the occupancy types A, B, E, & C3

Suitable for use in wind zones up to 55 m/s

Substrates - concrete, timber, steel Can be used with an offset handrail for D1 Access Route compliance

- F4 (Safety from falling) The product is manufactured under strict guidelines to ensure requirements under the building code are met and the product can not be penetrated, climbed over, or dislodged under normal operating conditions.
- **F9** (Pool fencing) When installed with appropriate gate hardware the product adequately complies with all applicable aspects of the building code.
