Product Description

Clearspan Classic is a traditional style framed glass balustrade with a modern twist. The secondary horizontal rail provides a subtle visual impact while the glass inserts offer unimpeded views. All Clearspan styles offer varying handrail options and fixing methods. Aluminium is extruded locally and fixings are high grade 316 stainless steel. Clearspan Classic is suitable in all architectural aesthetics and environments.

The system is suitable for residential, commercial*, external, internal & pool fence applications.

Fixing options include:

- Face fixed
- Top fixed
- Gutter Bracket (Castaway)

Surface finishes can be power coated or anodized in a range of standard colours.

Conditions of use

Clearspan Classic must be installed by Spectrum or an approved installer, and as per fixing details provided by Spectrum.

Scope of use

- **Product use**
Suitable for use on exterior balconies, decks and terraces, stairways and interior landings and stairways, or mezzanine floors
- **Occupancy type**
Suitability for the occupancy types A, B, E & C3
- **Building location**
Suitable for use in wind zones up to 55 m/s
- **Design parameters**
Fixing methods - top fixed, face fixed, gutter mount
Substrates - concrete, timber, steel Can be used with an offset handrail for D1 Access Route compliance

- B2 (Durability)** Manufactured from aluminium and stainless steel fasteners the product is designed and manufactured to provide a long service life when installed and maintained as per manufacturers guidelines.
- D1 (Access Routes)** When utilised as an access route solution the product is fully compliant providing it is manufactured and installed with the appropriate offset handrail.
- F4 (Safety from falling)** The product is manufactured under strict guidelines to ensure requirements under the building code are met and the product can not be penetrated, climbed over, or dislodged under normal operating conditions.
- F9 (Pool fencing)** When installed with appropriate gate hardware the product adequately complies with all applicable aspects of the building code.
