Product Description

Clearspan Face Hung Fin aluminium balustrade replicates the look of timber or steel balustrades with all the advantages of an aluminium balustrade system. Fins attach to the face of the structural frame providing a clean seamless look. Vertical fins can continue vertically to form privacy screens. A contemporary fin style, this balustrade system is designed for use in residential, commercial, aged care, and educational institutions where compliance up to C3 is required.

The system also includes a tubular offset handrail option for use on stairs, and can be used as part of a barrier enclosing a swimming pool

Fixing options include:

- Face fixed
- Top fixed
- Gutter Bracket (Castaway)

Surface finishes can be power coated or anodized in a range of standard colours.

Conditions of use

Clearspan Face Hung Fin must be installed by Spectrum or an approved installer, and as per fixing details provided by Spectrum.

Scope of use

- **Product use**
Suitable for use on exterior balconies, decks and terraces, stairways and interior landings and stairways, or mezzanine floors
- **Occupancy type**
Suitability for the occupancy types A, B, E & C3
- **Building location**
Suitable for use in wind zones up to 55 m/s
- **Design parameters**
Fixing methods - top fixed, face fixed, gutter mount
Substrates - concrete, timber, steel Can be used with an offset handrail for D1 Access Route compliance

- D1 (Access Routes)** When utilised as an access route solution the product is fully compliant providing it is manufactured and installed with the appropriate offset handrail.
- F4 (Safety from falling)** The product is manufactured under strict guidelines to ensure requirements under the building code are met and the product can not be penetrated, climbed over, or dislodged under normal operating conditions.
- F9 (Pool fencing)** When installed with appropriate gate hardware the product adequately complies with all applicable aspects of the building code.
