

### Product Description

Clearview Semi-Frameless Glass Balustrade absence of horizontal frame provides a sleek unobtrusive style for those all important views. Clearview Semi-Frameless is the traditional semi-frameless with no handrail. Toughened and laminated glass must be used in order to achieve compliance as a balustrade. Options with interlinking handrail include Clearview Offset & Clearview Capped. Aluminium is extruded locally and fixings are high grade 316 stainless steel.

The system is suitable for residential, commercial\*, external, internal & pool fence applications.

Fixing options include:

- Face fixed
- Top fixed
- Gutter Bracket (Castaway)

Surface finishes can be power coated or anodized in a range of standard colours.

### Conditions of use

Clearview Semi Frameless must be installed by Spectrum or an approved installer, and as per fixing details provided by Spectrum.

### Scope of use

- **Product use**  
Suitable for use on exterior balconies, decks and terraces, stairways and interior landings and stairways, or mezzanine floors
- **Occupancy type**  
Suitability for the occupancy types A, B, E & C3
- **Building location**  
Suitable for use in wind zones up to 55 m/s
- **Design parameters**  
Fixing methods - top fixed, face fixed, gutter mount  
Substrates - concrete, timber, steel Can be used with an offset handrail for D1 Access Route compliance

## Contributions to compliance

- B1 (Structure)** This product has been rigorously tested by a certified engineer to ensure full compliance with the relevant code.
- B2 (Durability)** Manufactured from aluminium and stainless steel fasteners the product is designed and manufactured to provide a long service life when installed and maintained as per manufacturers guidelines.
- D1 (Access Routes)** When utilised as an access route solution the product is fully compliant providing it is manufactured and installed with the appropriate offset handrail.
- F4 (Safety from falling)** The product is manufactured under strict guidelines to ensure requirements under the building code are met and the product can not be penetrated, climbed over, or dislodged under normal operating conditions.
- F9 (Pool fencing)** When installed with appropriate gate hardware the product adequately complies with all applicable aspects of the building code.
